Assessment Determination

If any species is categorised as Endangered or Critically Endangered on IUCN's Red List, or if it appears in the CITES appendices, it cannot be approved for use as MARINTRUST raw material. Anchovy, *Engraulis encrasicolus* do not appear as Endangered or Critically Endangered on IUCN's Red List, nor do they appear in CITES appendices; therefore, Anchovy, *Engraulis encrasicolus* is eligible for approval for use as MARINTRUST byproduct raw material.

One stock forms part of this assessment:

ICES Subarea 7

ICES is not aware of any agreed precautionary management plan for sardine in this area. Further, ICES cannot provide catch advice for this stock because of lack of reliable landings data. The level of discarding is unknown, and probably quite variable. The comparative lack of scientific information on the status of the population of the species means that a risk-assessment style approach must be taken. Consequently, the stock has been assessed under Category D.

The compliance rating for PSA has achieved a PASS. Hence, Anchovy, *Engraulis encrasicolus* in ICES Subarea 7 is **APPROVED** by GTC assessors for the production of fishmeal and fish oil under the current MARINTRUST v 2.0 by-products standard

Fishery Assessment Peer Review Comments

The assessor correctly classified anchovy in ICES Subarea 7 as category D, reference points are not defined to assess the stock status relative to.

A PSA was performed. With an average productivity score of 1.15 and an average susceptibility score of 2, the stock passes Table D3.

Therefore, the peer reviewer agrees with the assessor's determination that the fishery passes Table D3 and anchovy in ICES Subarea 7 is thus approved.

Species Categorisation

IUCN Redlist Category

- EXTINCT (E) AND EXTINCT IN THE WILD (EW)
- CRITICALLY ENDANGERED (CR) facing an extremely high risk of extinction in the wild.

In the case of mixed trawl fisheries, Category D species may make up the majority of landings. 


Figure 1. Distribution of *Engraulis encrasicolus* (European anchovy), with modelled year 2050 native range map based on IPCC RCP8.5 emissions scenario. www.aquamaps.org, version 10/2019.
