Assessment Determination
<p>Skipjack Tuna has been categorised as Least Concern by IUCN Red data List, and does not appear in CITES appendices. Therefore, it is eligible for approval for use as Marine Trust raw material.</p> <p>Skipjack tuna in the Indian Ocean are considered a single stock for stock assessment purposes. They are managed by the Regional RFMO, the Indian Ocean Tuna Commission, resolutions are binding on its members. Scientific advice is provided by the IOTC’s Scientific Committee. The latest stock assessment was undertaken in 2020.</p> <p>There is species-specific management and therefore the fishery is assessed under Category C.</p> <p>Fishery removals of the stock are considered in the stock assessment processes so the stock PASSES Clause C1.1.</p> <p>As of the latest assessment of stock status biomass is considered to be above the corresponding limit reference such that the stock PASSES Clause C1.2.</p> <p>As the stock passes both Clause C1.1 and C1.2, the by-product covered by this report is APPROVED for the production of fishmeal and fish oil under the current IFFO RS v 2.0 by-product standard.</p>
Fishery Assessment Peer Review Comments
<p>PR agrees that the species meets the MT pre-requisites and has been correctly assessed under Category C. The references provided support the conclusions of the Section C assessment and PR agrees with the assessor’s conclusion that the byproduct should be approved for use as a raw material.</p>

## Species Categorisation

### IUCN Red list Category

By-product material from a species listed by IUCN (the International Union for Conservation of Nature) under the Red List for the following categories shall immediately fail the assessment;

- EXTINCT (E) AND EXTINCT IN THE WILD (EW)
- CRITICALLY ENDANGERED (CR) facing an extremely high risk of extinction in the wild.
- ENDANGERED (EN) facing a very high risk of extinction in the wild.

By-product material may be used from the following categories provided that all clauses in the MarinTrust standard are passed.

- VULNERABLE (VU) facing a high risk of extinction in the wild.
- NEAR THREATENED (NT) does not qualify for above now, but is close or is likely to qualify for, a threatened category in the near future.
- LEAST CONCERN (LC) Widespread and abundant.
- DATA DEFICIENT (DD) and NOT EVALUATED (NE)

<p><b>C1.1 Fishery removals of the species in the fishery under assessment are included in the stock assessment process, OR are considered by scientific authorities to be negligible.</b></p> <p>Skipjack tuna is managed by the RFMO, the Indian Ocean Tuna Commission and its resolutions are binding on its members. Scientific advice is provided by the IOTC’s Scientific Committee supported by working parties. Fishery removals of the stocks in the fishery under this assessment are included in the IOTC stock assessment process with skipjack catches being available to view through the IOTC Online Data Querying Service.</p> <p>The Skipjack Tuna of Indian Ocean is assessed as one stock. The summary of 2021 estimates the stock status to be above the adopted target for this stock and that the current exploitation rate is just below the target.</p> <p>According to the 2020 summary of nominal catches, total Mauritian catches of skipjack tuna from the Western Indian Ocean in 2019 were 12,759 mt while total catches by all nations were 547,248 mt.</p> <p><b>C1.2 The species is considered, in its most recent stock assessment, to have a biomass above the limit reference point (or proxy), OR removals by the fishery under assessment are considered by scientific authorities to be negligible.</b></p> <p>A new stock assessment was carried out for skipjack tuna in 2020 using data up to 2019 (IOTC–2020–SC23–ES03). Stock status and current exploitation rate are estimated above target (<math>SSB_{2019}/SSB_{40\%SSB0} = 1.11 (0.95 - 1.29)</math>) and just below (<math>E_{2019}/E_{40\%SSB0} = 0.92 (0.67 - 1.21)</math>) their respective targets. Model-estimated spawning biomass remains above <math>SSB_{MSY}</math> (<math>SSB_{2019}/SSB_{MSY} = 1.99 (1.47 - 2.63)</math>) with very high probability.</p> <p>The summary states that the current spawning biomass relative to unexploited levels is at 45%. On the weight-of-evidence available in 2020, the skipjack tuna stock is determined to be: (i) above the adopted biomass target reference point; (ii) not overfished (<math>SB_{2019} &gt; SB_{40\%SB0}</math>); (iii) with fishing mortality below the adopted target fishing mortality, and (iv) not subject to overfishing (<math>E_{2019} &lt; E_{40\%SB0}</math>).</p> <p>As the stock is reported to have a biomass above the limit reference point, the stock achieves a PASS against C1.2.</p>		

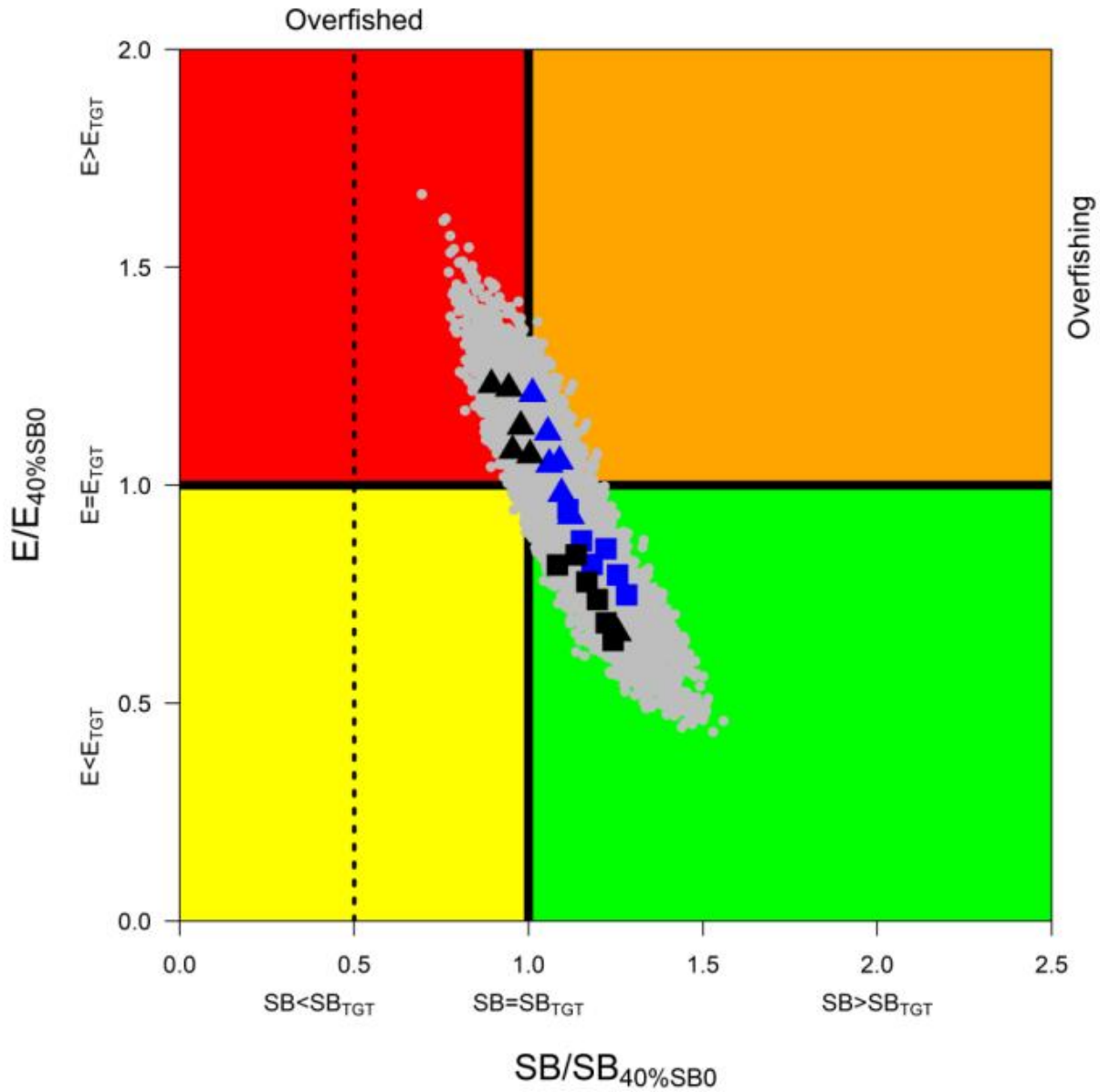


Fig 1. Skipjack tuna: SS3 Aggregated Indian Ocean assessment Kobe plot of the 2020 uncertainty grid. Symbols represent MPD estimates of current stock status relative to  $SB_{40\%SB0}$  (x-axis) and  $E_{40\%SB0}$  (y-axis) for the individual models (blue, no effort creep; black, additional effort creep; triangle, full weighting of tagging data; square, tagging data downweighted). Grey dots represent uncertainty from individual models. The vertical dashed line represents the limit reference point for Indian Ocean skipjack tuna ( $SBlim = 20\%SB0$ )

Category D species are those which are not subject to a species-specific management regime. In the case of mixed trawl fisheries, Category D species may make up the majority of landings. The comparative lack of scientific information on the status of the population of the species means that a risk-assessment style approach must be taken.
