## Table 2. Assessment Determination

Assessment Determination
<p>Indian oil sardine has been categorised by the IUCN as a species of Least Concern and does not appear in the CITES appendices. There does not appear to be any evidence of reference points or species-specific management measures for Indian oil sardine in the Western Pacific. At least two sources indicate that the species is not present in the Pacific Ocean<sup>1,2</sup>. Due to the absence of reference points, and on the assumption that is not entirely absent from the region, the byproduct was assessed under Category D.</p> <p>Indian oil sardine in the Western Pacific was awarded a Productivity score of 1 and a Susceptibility score of 2.5, leading to a Pass rating against Table D3. Therefore, it meets the MT requirements and should be approved for use as a raw material.</p>
Fishery Assessment Peer Review Comments
<p>The by-product fishery under assessment is the Indian oil sardine (<i>Sardinella longiceps</i>) caught with purse seine and pelagic trawls in FAO areas 61 and 71 (Pacific Ocean, Northwest and West-Central). The species is listed as LC in the IUCN red list. No reference points have been defined for this stock and no information on management has been found. Therefore, the stock is assessed under category D and a productivity susceptibility analysis (PSA) is undertaken.</p> <p>The stock awards a Productivity Score of 1 and a Susceptibility Score of 2.5, leading to a Pass rating on Table D3.</p> <p>The peer review supports the auditor’s recommendation to pass the Indian Ocean sardine caught with purse seine and pelagic trawls in the Northwest and West-Central Pacific (FAO areas 61 and 71) under the Marin Trust IFFO RS v2.0 by-fishery standard for the production of fishmeal and fish oil.</p>

## Species Categorisation

**NB:** If any species is categorised as Endangered or Critically Endangered on the IUCN Red List, or if it appears in CITES Appendix 1, it **cannot** be approved for use as a MarinTrust raw material.

### IUCN Red list Category

By-product material from a species listed by IUCN (the International Union for Conservation of Nature) under the Red List for the following categories shall immediately fail the assessment;

- EXTINCT (E) AND EXTINCT IN THE WILD (EW)
- CRITICALLY ENDANGERED (CR) facing an extremely high risk of extinction in the wild.
- ENDANGERED (EN) facing a very high risk of extinction in the wild.

By-product material may be used from the following categories provided that all clauses in the MarinTrust standard are passed.

- VULNERABLE (VU) facing a high risk of extinction in the wild.
- NEAR THREATENED (NT) does not qualify for above now, but is close or is likely to qualify for, a threatened category in the near future.
- LEAST CONCERN (LC) Widespread and abundant.
- DATA DEFICIENT (DD) and NOT EVALUATED (NE)

## CATEGORY C SPECIES


In a by-product assessment, Category C species are those which are subject to a species-specific management regime and are usually targeted species in fisheries for human consumption.

## CATEGORY D SPECIES

Category D species are those which are not subject to a species-specific management regime. In the case of mixed trawl fisheries, Category D species may make up the majority of landings. The comparative lack of scientific information on the status of the population of the species means that a risk-assessment style approach must be taken.
